UPDATE

Dear Fraters.

One of the Foundation's goals is to promote transparency with its donors. Every penny we bring in and spend is in support of the Foundation's mission and in strict adherence with our non-profit, 501(c)3 status.

Year to Date in 2023, the Foundation has brought in \$33,935 in donations from our generous alumni. Our top four donors for the year include James Boshuetz, Robert Yeoman, Ed Moy, and Paul Aspinwall.

During the year, the Foundation provided two \$1,000 scholarships to our undergraduates and provided \$2,000 in funds to our members to attend the Regional Leadership Conference. \$26,500 of the donations were transferred to our Legacy Fund. The balance of those donations was spent on our annual newsletter, awards for undergraduates and alumni, as well as our Career Panel educational modules.

Speaking of the Legacy Fund, the Foundation is establishing an account with a goal to provide annual reoccurring scholarships to our undergraduate members without having to tap into the general account funds. This structure will ensure that undergraduates receive these scholarships long after our current board has moved on. We have a formalized Investment Policy Statement in place with several funding options on the table. We are also establishing an Investment Committee to govern. We want to grow this account so that we can award more or larger scholarships in the future.

Overall, the Foundation is operating from a position of strength. Our general account currently has approximately two years of operating expenses in reserve. However, we can always use your support. Donald J. Bielski '77

Don received his undergraduate degree in 1981, and then attended the University of Wisconsin Law School, graduating cum Laude in 1984. He was a staff attorney for the Kenosha Public Defender's Office from 1984 to 1997. In 1997, he opened his own practice in Kenosha, where he remains to this day. In addition to criminal and misdemeanor cases, Don is also involved in child welfare cases where he is also an instructor for the State Bar. In 2008-2009, he served as president of our local bar association. In the community, he has served on the board of Women's Horizons and also served on the board of the Hope Council, a alcohol and drug treatment referral service. Don has served on the Lambda Chapter Building Corporation board since 2008, serving as secretary since 2009 until the present day, and occasionally providing legal advice.



David Nelson '77

David received his BA from the University of Wisconsin in 1978, majoring in economics and international relations. While a Senior, he passed the Foreign Service exam, and joined the US Department of State in 1979. As a Diplomat, David represented the United States in 7 overseas assignments, including as US Ambassador to Uruguay. He also served in several senior positions domestically, including at the National Security Council and in leadership functions in the Economic and Business Bureau of the Department of State. After retiring from the Foreign Service in 2011, David continued to work in the public policy arena. In 2018, he founded a consulting firm — Global Business Policy-DC, helping US firms such as Cargill succeed in the global economy.



Paul Hanson '78

Paul started working for Miller Brewing Co in 1980 in college marketing. A highly successful career with many promotions eventually brought him to his last position, Vice President of Sales. He retired in 2018, and in August 2020 launched Iron Joc Performance Gear. https://ironjoc.com/ which competes with other brands such as Under Armor, Nike, and Adidas. Iron Joc has a proprietary fabric that provides wicking, cooling, 4 way stretch, anti-static, water repellency, and stain blocking. As a result, when you sweat the silver ions kill 99.9 of the bacteria. His awards include being named employee of the year for Sales and Marketing in 1992, 1999, and 2010, and Leader for Women's Development and Mentoring at Miller Coors.

He was selected to join Cardinal Health's Leadership Development program in 2017; only 2 years after joining company.
